Bequest or Legacies

- Bequests or Legacies are favoured by many who wish to make a donation and a difference. A legacy can be money, shares or other assets. A gift of this kind also helps to reduce any potential inheritance tax liability. If you would like more information please tick the box.

Stocks and Shares

- Individuals are eligible for tax relief on gifts of certain shares, securities and other investments. This is in addition to capital gains tax relief on gifts of assets to charities. Tax relief is based on the value of the shares on the day they are transferred. This is a particularly valuable way of giving which might suit some donors. Donors will claim this tax relief from the Inland Revenue on their tax return. If you would like to support the YACHT Appeal by gifting shares and would like more information please tick the box.

Payroll Giving

- A flexible and tax advantageous way to give; also known as Give as You Earn. The amount donated is deducted from pay before tax, and so pledging £25 per month costs the basic tax payer £20 and the taxman pays the rest. For the higher rate taxpayer it is the only way of passing that higher rate to the charity. Further information can be provided by the Treasurer to anyone whose employer operates such a scheme.
